ELIGIBILITY: USATT membership required. Open to residents of Alabama including students and military stationed in the state. **Players must provide proof of current membership or purchase membership or pass to participate** (available on this form).

FORMAT: **Championship and U-1500 singles** events will be round robin in the first round with **ALL** players advancing to a single-elimination playoff.

FIRST ROUND: Players will be grouped in 4's or 5's using "snake" system in accordance with USATT Tournament Guide. **Playoffs:** Top two players from each group in the Championship singles will advance to Championship. All others will advance to Class A.

In the U-1500 singles, the top two players for each group will advance to Class B. The remaining players will advance to Class C.

Players may not enter both Championship and U-1500 RR singles events and may enter only one doubles event.

Seniors, Esquires, juniors and women will be RR with group size depending on number of participants.

Doubles events will be single elimination. **Deadline to signup for doubles is noon.**

All finals will be the best 4 out of 7 games. All other matches will be 3 out of 5 games.

The Championship singles and Championship doubles winners are declared the official 2011 Alabama singles and doubles champions.

SCHEDULE: Championship and U-1500 RR singles play starts at 9 a.m. Seniors, Esquires, juniors, women will begin at 1 p.m. Doubles will begin at 2 p.m. Players must register no later than **30 minutes prior** to starting time. Players not on time may be defaulted. Facilities open at 8 a.m. for practice. Also open Friday night 6-9 p.m..

From Southbound I-65: Take Exit 340A, toward Decatur; cross the 6th Ave. bridge. Proceed South on 6th Ave / US-31 2.3 miles to 14th St. SW, turn right (**Liberty Gas Station** near intersection). Cross bridge over RR tracks, turn right at light onto Central Pkwy. After ½ mile turn left onto 8th St. Turn left on 5th Ave after passing Aquadome (parking is from 5th Ave.)

From Northbound I-65: Take Exit 334, turn left onto Ala. 67, go about 4 miles, turn right on U.S. 31 (6th Ave). Go about 1 mile, turn left on 14th Street SW. (**Liberty Gas Station**, **Peoples Bank** near intersection). See Southbound directions.
